Student / Parent Contract

As a 2020-2021 Vocal Department (AMT, Vocal Ensemble, and/or Choir) student and parent, I understand that:

1. **I will** abide by all classroom rules and procedures.
2. **I will** abide by the Volusia County Student Code of Conduct.
3. **I will** maintain a 2.0 GPA (with no Ds or Fs on report card) along with regular school attendance.
4. **I will** participate in all scheduled Vocal Department rehearsals and performances during and after school, and understand that **all rehearsals and performances are mandatory**.
5. **I will** be a positive representative of Seabreeze High School on and off campus.
6. **I will obtain and wear** proper choir attire during all Vocal Department events. Choir attire to be set by Vocal Department Director at beginning of School year.
7. (AMT only) **I will obtain and wear** proper dance attire during rehearsals.
 - Clothes that allow freedom of movement as well as remain within the Volusia County Dress Code.
 - Dance shoes as needed for show.
8. (AMT / Vocal Ensemble or Vocal Ensemble) **I understand** that financial responsibilities, behavior, attendance, as well as both student and parent participation in Vocal Department activities, will be tallied at the end of the year and recorded on each student's AMT / Vocal Ensemble Audition form for the next year. For all students desiring to return for the next year, these scores will be measured, along with the talent audition, to evaluate the level of commitment of each student and their parents.
9. (AMT / Vocal Ensemble or Vocal Ensemble) **I understand** that I may not audition for AMT and/or Vocal Ensemble without my and my parent's signature on this contract.

10. (AMT only) **I understand** that failure to audition for casting will result in being cast in the the production's ensemble or in backstage operations.
11. (AMT or Vocal Ensemble) **I understand** that I must re-audition each year and acceptance back into the program is not guaranteed.
12. (AMT / Vocal Ensemble or AMT / Choir) **I accept** and adhere to the following financial obligations and responsibilities:
 - **AMT / Vocal Ensemble or AMT / Choir obligation of \$500.00 is due in full by September 30, 2020**
 - The obligation can be paid by parents, raised through program sponsorships, or a combination of both.
13. (Choir Only or Vocal Ensemble Only) **I accept** and adhere to the following financial obligations and responsibilities:
 - **Choir obligation of \$125 is due in full by September 30, 2020**
 - The obligation can be paid by parents, raised through program sponsorships, or a combination of both.
14. Vocal Department fundraisers may be conducted throughout the summer and school year. The monies raised through Vocal Department fundraisers will be used to help offset additional costs to the program and/or any field trips the program has scheduled.
15. (Parents) **At least one parent/guardian must actively participate in one of the Vocal Department Committees.**
